Sanlam Gap 2026 Benefit Changes

Premium Increase for 2026

The rate for individual members will increase by an average weighted increase of 6.58%.

Premium adjustments will vary by **employer group** but Sanlam Gap introduced an average weighted increase of 4.84% for corporate clients.

2026 Benefit Enhancements:

Sanlam Gap Comprehensive plan:

- Overall annual limit increases to R219,845 per insured person per year.
- Benefit limits increases by 6%.



Sanlam Gap 2026 Benefit Changes

Specific benefit enhancements

Sanlam Gap Comprehensive plan:

- Oncology Tariff Shortfall Benefit: Increased from 500% to 600%.
- Oncology Agreed Benefit: Increased from R15,500 to R30,000.
- Innovative Oncology Medicines Benefit: Increased R14,250 to R20,000 per cycle.
- Sub-limit Shortfall: Increased from R66,400 to R68,500.
- Family Booster Benefit: Increased from R16,400 to R16,900.

New Benefit introduced on the Comprehensive option.

Breast Cancer Reconstruction Benefit:

Provides an agreed benefit amount of R30,000 payable for reconstruction of the unaffected breast after mastectomy due to breast cancer.



2026 Benefit Enhancements

Specific benefit enhancements

Sanlam Gap Core plan:

- Sub-Limit Benefit: Increased from R31,800 to R32,800 per event.
- Penalty Co-Payment Benefit: Increased from R12,270 to R12,650, with a maximum of one event.

New Benefits introduced on the Core option.

Emergency Casualty Benefit:

- Accident only: Up to R18,450 per event.
- Any after-hours treatment in a casualty ward is limited to two events per year, maximum R3,000
 per event for children under age 12.

Family Protector Benefit introduced (accident only):

- R20,000 per child below 6 years of age.
- R30,000 per member for all other insured parties.



2026 Benefit Enhancements

Mediclinic Extender

The Mediclinic Extender enhancements are:

- Casualty Illness Cover: Increased from R2,800 to R3,000.
- Cancer Agreed Benefit: Increased from R10,900 to R20,000.
